ADDITIONAL INFORMATION:

- RACE ACCOUNTS: for K1, K2 and J.** At the time of registration, a \$500 race account deposit will be required for each athlete in addition to the program fee. These funds are used to pay for individual expenses (training, race fees, lift tickets, coach expenses, etc) for events you may attend throughout the season. Race expenses are calculated for each athlete and are based only on the events or training sessions you attend. You will be asked to top up your accounts during the season as required and any unused funds in your race account will be reimbursed to you at the end of the season. Please refer to the race accounts policy for more information.
- UNIFORMS** are mandatory for all members. HOWEVER, the cost of uniforms is not included in the membership fees. For new Race Kids (E1,E2) and Race Tigers an additional \$75.00 will be added to the base membership fee to cover the costs of a new Halti vest embroidered with the VSC logo. Used vests may be available for private purchase and the club will advertise the availability of used vests wherever possible. For K, J and FIS members, Halti club jackets can be purchased through the club's uniform coordinator. Please check the website for details and contact information.
- BC Alpine** is our provincial sporting organization and is affiliated with Alpine Canada Alpin, our national sanctioning body. BC Alpine fees provide insurance coverage which is mandatory for all skiers and volunteers participating in a ski program. Parents involved with *any* aspect of the club either on or off snow must be registered with BC Alpine for insurance purposes. This includes skiing with your child's group (even though you may not be coaching), volunteering for events or using any of the club facilities. The Family Membership fee includes BCA fees for 2 parents as well as use of the VSC cabin for the family.

VSC Program Fees Include

- All coaching on core program days (K/J program includes Christmas Camps)
- Additional coaching for 'fun' days that may be designated outside the core program
- Use of VSC equipment as required by the coaching staff (including gates, timing equipment, etc)
- Coaching for zone race events.



Summary of Membership Fees – 2009/2010 Season

- Local “fun” days or other designated local club events
- Fall dryland training for K/J/FIS athletes

VSC Program Fees DO NOT include:

- Lift tickets and Race entry fees
- Accommodation or travel expenses for ‘away’ races
- Off-season dryland or additional training programs.
- Additional coaching expenses for ‘away’ races (refer to the “Race Accounts” policy for additional details)
